Abduction *ARREST – On May 2, the suspect, identified as Elith Samuel **PARADA**, who was sought in connection to the abduction that was reported to have occurred at a residence located in the 2700 block of Burrough Hill Ln. in Woodbridge (22191) on April 21, was arrested.

Abduction [Previously Released] – On April 21 at 10:30PM, officers responded to a residence located in the 2700 block of Burrough Hill Ln. in Woodbridge (22191) to investigate an abduction. The investigation revealed the victim, a 23-year-old woman, and her landlord, identified as the accused, were involved in a verbal altercation. At one point, the accused physically prevented the victim from leaving the home. After an extended period of time, the victim was able to exit the residence and contacted the police. No injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Elith Samuel **PARADA**, who remains wanted.

Incidents

Shooting into a Residential Dwelling – On May 3 at 12:21AM, officers responded to a residence located in the 16600 block of Flotilla Way in Woodbridge (22191) to investigate a shots fired call. The investigation revealed multiple shots were fired before a man was observed leaving the area. A home and three unoccupied vehicles were struck by gunfire. No injuries and no additional property damage were reported. While investigating the incident, officers located shell casings in multiple locations, including inside the residence and in the roadway.

School Threat Investigation – On May 2 at 12:18PM, the School Resource Officer (SRO) of Freedom High School located 15201 Neabsco Mills Rd. in Woodbridge (22191) was notified of a rumored threat towards the school. The investigation revealed the rumor was overheard by multiple students and then reported to school personnel who notified the SRO. The school adjusted their operation status as a precaution while the SRO conducted the investigation and determined there was no credible threat to the school.

Commercial Burglary – On May 3 at 4:53AM, officers responded to Sephos located at 2830 Garber Way in Woodbridge (22192) to investigate a burglary. The investigation revealed a suspect forced entry into the business through the front door where he attempted to gain access to the cash register. The suspect took a donation jar before leaving through the rear of the business. The suspect was described as wearing a grey hooded jacket and black gloves.
